Your bid for approximately 550 CCF of decked forest products on the Allegheny National Forest has been accepted and the sale is hereby awarded to you under designation 2450 – New Shawmut Timber Company, 03-155960, Warrant 2752 Deck Sale, 10/17/2008.

Your attention is called to the requirement on your bid that within 30 days of the date of this letter, you must execute and return the decked sale contract, make full payment of the total sale value for products and road maintenance, and furnish a satisfactory performance bond. Failure to provide any one of these requirements shall result in the termination of this contract for breach and the bid guarantee shall be retained and applied to damages. The bid guarantee of \$ 11,000 in the form of a cashier's check that accompanied your bid has been retained and will be applied against the sale value.

Enclosed are two copies of the timber sale contract and form SF-25 – Performance Bond. Both copies of the contract should be signed by you. The performance bond should be signed by you and executed by corporate surety. If the bond is executed by corporate surety, please request a Power of Attorney be attached to original of performance bond. If bond will be satisfied by a Letter of Credit or deposited securities, please so indicate on bond form and submit original Letter of Credit or security when returning. Please be sure that the termination date of the irrevocable Letter of Credit is one year beyond the termination date of the contract, which is December 31, 2008. Savings accounts or Certificates of Deposits may be assigned to satisfy the performance bond. Please contact us promptly if you are interested in pursuing this method. All signed copies of these documents are to be returned to the Contracting Officer. The Contracting Officer will execute the contract, approve the bond, and return one set for your records.
