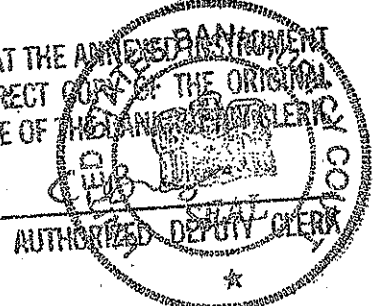

The Joint Plan of Reorganization (the "Plan") under Chapter 11 of the Bankruptcy Code filed on or about January 3, 2004, as modified by the Immaterial Modifications to Joint Plan of Reorganization on April 16, 2004, and the Second Immaterial Modifications to Joint Plan of Reorganization filed on April 19, 2004, (hereinafter collectively referred to as the "Plan") by AZCO OPERATING COMPANY ("AZCO OPERATING"), AZCO OIL COMPANY, INC. ("AZCO OIL"), PENNECO PRODUCTION COMPANY, INC. ("Penneco"), and CHERRY RUN TRANS-COUNTY, L.L.C. ("Cherry Run"), the Debtors and Debtors-in-Possession in the above-captioned Bankruptcy Cases (collectively, the "Corporate Debtors"), and the Plan and Disclosure Statement approved by the Court having been served on holders of all claims and equity security interests in the cases of the Corporate Debtors (the "Corporate Cases"); and copies of the Notice of Hearing on Confirmation of Chapter 11 Plan having been served upon all creditors, equity security holders and parties-in-interest, in accordance with the Special Procedures Order, and

It having been found and determined by this Court, after notice and hearing pursuant to 11 U.S.C. §1128(a) and Rule 2002(b), Fed.R.Bankr.P., that:

1. The Plan complies with the applicable provisions of the Code;
2. The Corporate Debtors have complied with the applicable provisions of the Code;
3. The Plan has been proposed in good faith and not by any means forbidden by law;
4. Any payment made or to be made by the Corporate Debtors or any person issuing securities or acquiring property under the Plan, for services or for costs

and expenses in or in connection with the case, or in connection with the Plan and incident to the case, has been approved by, or is subject to the approval of, the Court as reasonable;

5. The Corporate Debtors have disclosed the identity and affiliations of any individual proposed to serve, after Confirmation of the Plan, as a director, officer or voting trustee of the Corporate Debtors, the appointment to or continuance in such office of such persons is consistent with the interest of creditors and equity security holders and with public policy; and the Corporate Debtors have further disclosed the identity of all insiders who will be employed by the Debtors and the nature of any compensation for said insiders;

6. With respect to each impaired class of claims or interests, each holder of a claim or interest of such class has accepted the Plan or will receive or retain under the Plan on account of such claim or interest, property of a value, as of the Effective Date of the Plan, that is not less than the amount that such holder would receive or retain if the Corporate Debtors were liquidated under Chapter 7 of the Bankruptcy Code;

7. With respect to each class of claims or interests, each such class has accepted the Plan or the applicable elements of 11 U.S.C. §1129(b)(2) have been satisfied as to that class;

8. Except to the extent that the holder of a particular claim has agreed to a different treatment of such claim, the Plan provides that:

A. With respect to each claim of a kind specified in 11 U.S.C. §§507(a)(1) or 507(a)(2) of the Code, on the Effective Date of the Plan, the holder of each such claim will receive on account of such claim cash equal to the allowed

amount of such claim;

B. With respect to a class of claims of a kind specified in 11 U.S.C. §§507(a)(3), 507(a)(4), 507(a)(5), 507(a)(6) or 507(a)(7) of the Code, each holder of a claim of such class will receive, if such class has accepted the Plan, deferred cash payments of a value, as of the Effective Date of the Plan, equal to the allowed amount of such claim; or, if such class has not accepted the Plan, cash on the Effective Date of the Plan, equal to the allowed amount of such claim; and

C. With respect to a claim of a kind specified in 11 U.S.C. §507(a)(8) of the Code, the holder of each such claim will receive on account of such claim deferred cash payments, over a period not exceeding six years following the date of assessment of such claim, of a value, as of the Effective Date of the Plan, equal to the allowed amount of such claim.

9. Nine classes of claims that are impaired under the Plan have accepted the Plan, determined without including any acceptance of the Plan by an insider holding a claim of such class;

10. Confirmation of the Plan is not likely to be followed by the liquidation, or the need for further financial reorganization, of the Corporate Debtors or the Reorganized Debtor under the Plan;

11. All fees payable, pursuant to 28 U.S.C. §1930, have been paid or the Plan provides for the payment of all such fees on the Effective Date of the Plan;

12. The Corporate Debtors provided no retiree benefits, as that term is defined in 11 U.S.C. §1114; therefore, the requirements of 11 U.S.C. §1129(a)(13) are inapplicable to the case at bar and the Plan; and

13. The Plan meets the requirements of 11 U.S.C. §§1122 & 1123.

IT IS HEREBY ORDERED that the findings set forth above and conclusions of law stated herein below shall constitute the Court's findings of fact and conclusions of law, pursuant to Rule 7052, Fed.R.Bankr.P., made applicable to this proceeding pursuant to Rule 9014, Fed.R.Bankr.P. To the extent that any findings of fact shall be determined to be a conclusion of law, it shall be so deemed and *vice versa*;

IT IS FURTHER ORDERED that all objections to confirmation of the Plan have been resolved as set forth below, have been withdrawn or to the extent necessary are, hereby, overruled for the reasons stated on the record on April 26, 2004;

IT IS FURTHER ORDERED that the Disclosure Statement approved by Order of the Court dated February 26, 2004 contains adequate information for the Plan proposed by the Debtors;

IT IS FURTHER ORDERED that the modifications to the Plan set forth in the Immaterial Modifications to Joint Plan of Reorganization filed by the Corporate Debtors on April 16, 2004, and the ~~Second Immaterial~~ Modifications to Joint Plan of Reorganization filed by the Debtors on April 19, 2002 are not material and do not modify the Plan so that it fails, as so modified, to meet the requirements of 11 U.S.C. §§1122 & 1123, and those modifications are incorporated into and are a part of the Plan;

IT IS FURTHER ORDERED that pursuant to Bankruptcy Code §§ 365, 1123(a)(5)(D), 1123(b)(2) and 1123(b)(4), the Debtors are authorized to transfer all of their property and assets free and clear of all liens, claims, charges, assignments and interests, and all liens on such assets shall attach to the proceeds thereof, with the same validity, priority, force and effect to the extent expressly provided for under the Plan.

IT IS FURTHER ORDERED that upon the Effective Date of the Plan, the AZCO Office Property (described at Warren County Record Book 787, Page 241, which description is incorporated by reference), AZCO Wells (excluding the Abandoned Wells), Business Assets, Transferred Claims and any other property or assets described as being transferred to New AZCO in the Plan, shall be transferred to Duhring Resource Company (the entity which will fill the role of New AZCO) free and clear of all claims, liens, charges, assignments and interests of parties asserting such interests, including creditors, co-owners, assignees or the like, arising prior to Confirmation, except as otherwise expressly provided for in the Plan.

IT IS FURTHER ORDERED that upon the Effective Date of the Plan, the Cherry Run Pipeline, the Pipeline Lease and any other property or assets described as being transferred to New Cherry Run in the Plan, shall be transferred to Tionesta Valley Pipeline Co. (the entity which will fill the role of New Cherry Run) free and clear of all claims, liens, charges, assignments and interests of parties asserting such interests, including creditors, co-owners, assignees or the like arising prior to Confirmation, except as otherwise expressly provided for in the Plan.

IT IS FURTHER ORDERED that the Plan and Order is binding on all persons or entities described in the Plan and served with copies of the Plan and Disclosure Statement, including, but not limited to, the persons and entities listed on the Plan's Schedules or on Exhibit "A" attached to this Order. Duhring Resource Company (New AZCO) and/or Tionesta Valley Pipeline Co. (New Cherry Run) (collectively, Duhring Resource Company and Tionesta Valley Pipeline Co. are hereinafter referred to as the "Transferees") may cause the Plan and this Order to be indexed in any appropriate

jurisdiction as against one or more of those persons or entities as the Transferees shall see fit.

IT IS FURTHER ORDERED that (a) the Transferees shall not assume any responsibility for any liabilities, obligations or claims against the Debtors except as expressly provided for in the Plan; (b) the Transferees are not successors to the Debtors under any contracts that are not assumed under the Plan; and (c) except as otherwise expressly provided in the Plan or this Order, all persons or entities who have held, hold, or may hold claims against, or interests in, the Debtors or their Estates will be permanently enjoined on and after the Effective Date, from (i) the enforcement, attachment, collection or recovery by any manner or means of any judgment, award, decree or order against the assets or property of the Estates, against the Estates or against the proceeds of such property or assets, including without limitation property or assets transferred to the Transferees (except as expressly provided for in the Plan), on account of any such claim or interest, (ii) creating, perfecting or enforcing any encumbrance of any kind against the property, assets or interests of the Debtors transferred to the Transferees, and (iii) asserting any claim or interest against the Transferees.

IT IS FURTHER ORDERED that the aggregate amount of the allowed priority claims of the United States Internal Revenue Service (the "IRS") in the Corporate Cases is \$168,553.88 (AZCO OIL priority claim of \$138,691.16, AZCO Operating priority claim of \$25,661.14 and Penneco priority claim of \$3,200.88) and the aggregate amount of the IRS' allowed administrative claim of \$3,753.94, pursuant to the Second Immaterial Modifications, shall be paid in full on the Effective Date of the Plan and all other claims of the IRS are general unsecured claims which shall be treated in Class 4 of

the Plan;

IT IS FURTHER ORDERED that the Corporate Debtors and Vernon Schweigert, the Trustee in the bankruptcy case of Thomas and Patricia May, shall implement a procedure for the determination of the value of the assets to be transferred from the May bankruptcy estate under the terms of the Plan; that is, either a valuation hearing or a motion to approve the sale of those assets and shall reserve the sum of \$15,539.81 in the estates of the Corporate Debtors in order to preserve the ability to pay the fees and costs of Dale Ulrich and Terry Dake, if and when allowed by this Court as administrative claims in the Corporate Cases. The creation of the reserve is without prejudice to seek allowance of additional fees and costs incurred in responding to the objections to their fee applications. ;

IT IS FURTHER ORDERED that the Corporate Debtors shall reserve the sum of \$12,000 in the estates of the Corporate Debtors in order to pay an unsecured claim of Snyder Brothers, Inc., if and when allowed by the Court as an administrative claim under 11 U.S.C. §502(f) or other applicable provisions the Bankruptcy Code; and

IT IS FURTHER ORDERED that the Joint Plan of Reorganization filed by the Debtors on January 3, 2004, a copy of which is attached hereto as Exhibit "B," as modified by the Immaterial Modifications to Joint Plan of Reorganization filed by the Corporate Debtors on April 16, 2004, and the Second Immaterial Modifications to Joint Plan of Reorganization filed by the Debtors on April 19, 2002 and further by the incorporation of the above-referenced language, is confirmed.
